4. Vendors are required to supply their own power source if needed.
5. Vendors are responsible for removing their own trash.
6. This event is family based, if any literature or giveaways are deemed inappropriate you will be asked to remove those items.
7. Vendors are encouraged to assign someone from their organization to obtain food and beverages for the business/group/organization from the food court.
